It is an offence, if any person, for any purpose connected with the FNPF Act:-

- i) knowingly makes a false statement or
- ii) produces or furnishes or causes or knowingly allows to be produced or furnished any document which he knows to be false in a material particular.

Re-Entry - If at any time you should decide to return to Fiji to reside and work and wish to re-join as a member of FNPF, you would be required to do so within 3 months of your re-employment in Fiji.

Who Completes this form

- A member who is a Fiji citizen and is migrating or has already migrated or has already migrated to settle permanently overseas.
- An expatriate member who has completed his employment contract in Fiji and is returning to his/her country.

Documents to submit with this application

1. Certified copies of the first two pages of your passport showing your identification and passport validity.
2. Your Visa for permanent residency for country of migration (*Fiji Citizens only*)
3. Evidence of employment termination:-
 - **Fiji Passport Holders** - Employer's letter accepting your resignation (*if employed within the last year*).
 - **Foreign Passport Holders** - Contact termination letter from your employer and a copy of your work permit.
4. One-way ticket or travel itinerary
5. Confirmation of current/valid bank account details.

Remittance of funds to overseas address

There are exchange control rules set by the Reserve Bank of Fiji (RBF) for the remittance of funds outside of Fiji. FNPF will transfer your payments to your overseas address provided the amount payable is within RBF regulations. Refer RBF for current regulations. If funds payable are in excess of the RBF limit, then it will be your responsibility to obtain a permit from RBF and make arrangements for the transfer of funds.

Method of Payment

- i) **Bank Deposit:** Ensure that you bank account is correctly written in this form. Telegraphic transfers are permitted. Note that your payment cannot be deposited into an account which is not in your name.
- ii) **Mailing:** Please provide a reliable overseas postal address for bank draft.
- iii) **Payment through Bank Disbursement:** For members who do not have Bank accounts. Funds are transferred to a special account at the bank and members are paid cash on producing FNPF identification and confirmation that funds have been transferred. FNPF photo ID is required.
