- 1. Your age at the time of withdrawal should be 50 years or more
- 2. You should be unemployed for over 3 years
- 3. You should have a balance of \$2000 or less in your FNPF account
- 4. You will not be eligible for pension

Documents to submit with this application

- 1. Certified copy or original birth certificate
- 2. Evidence from your bank confirming your account number for payment deposits
